**A BYLAW TO REPEAL THE ISSUANCE OF TICKETS BYLAW # 313, 1993**

**“A BYLAW TO DESIGNATE THOSE BYLAWS OF THE DISTRICT OF PORT EDWARD WHICH MAY BE ENFORCED BY MEANS OF A FORM OF TICKET.”**

**WHEREAS** Section 264 of the Community Charter authorizes the Council to, by bylaw:

- i) designate those bylaws which may be enforced by means of a Ticket Information;
- ii) designate bylaw enforcement officers, a person who comes within a class of persons prescribe by regulation, and
- iii) designate an offence against a bylaw by means of a word or expression on a Ticket Information;

**AND WHEREAS** Section 265 of the Community Charter authorizes Council to by bylaw:

establish a fine in relation to an offence not greater than \$1,000 for the contravention of a bylaw;

**AND WHEREAS** the Council deems it desirable and expedient to authorize the use of Ticket Information for the enforcement of certain bylaws, to designate persons as bylaw enforcement officers, to designate offences against a bylaw by means of words or expressions, and set certain fine amounts;

**NOW THEREFORE** the Council of the District of Port Edward in open meeting assembled, enacts as follows:

**1. BYLAW ENFORCEMENT BY TICKET**

The bylaws listed under Column 1 of Schedule 1 to this bylaw may be enforced by means of a Ticket Information in the form prescribed for the purpose of Section 264 (1) (a) of the Community Charter.

**2. BYLAW ENFORCEMENT TICKET**

The persons appointed to the job positions or titles listed in Column 2 of Schedule 1 to this bylaw are designated as Bylaw Enforcement Officers pursuant to Section 264 (1) (b) of the Community Charter for the purpose of enforcing the bylaws listed in Column 1 of Schedule 1 opposite the respective job positions or titles.

**3. OFFENCES**

The words or expressions set forth in Column 1 of Schedules 2 through 11 to this bylaw designate the offence committed under the bylaw section number appearing in Column 2 of Schedule 2 through 11 to this bylaw opposite the respective words or expressions in Column 1.

**4. FINES**

The amounts appearing under Column 3 of Schedules 2 through 11 to this bylaw are the fines set pursuant to Section 265 of the Community Charter for the corresponding offences designated under Column 1.

**5. REPEAL**

This bylaw hereby repeals and replaces the "District of Port Edward Ticket Information Utilization Bylaw No. 313, 1993" and amendments thereto.

**6. EFFECT**

This bylaw shall take effect upon the date of its adoption. Amendments shall come into force upon date of adoption or by an effective date noted in the respective bylaw.

**7. CITATION**

This bylaw shall be cited for all purposes as "Ticketing Information Utilization Bylaw # 522, 2011.
